
MUSICAL PERFORMANCE AGREEMENT

1. ENGAGEMENT DETAILS

2. COMPENSATION & PAYMENT

3. TECHNICAL REQUIREMENTS

- **Vocal Production:** Five (5) high-quality wireless handheld microphones with fresh batteries.
- **Backline:** One (1) professional drum kit (minimum 4-mic setup) on an 8'x8' carpeted riser; dedicated DI or amps for Bass, Keys, and Guitar.
- **Horn Section:** Two (2) dedicated instrument microphones on stands.
- **Monitoring:** Minimum of 4–6 separate monitor mixes (In-Ear or Wedges) to be managed by a qualified sound technician provided by the Purchaser.

4. HOSPITALITY & TRAVEL

- **Dressing Rooms:** Two (2) clean, lockable private rooms with mirrors, seating, and climate control.

- **Catering:** Purchaser shall provide 12 hot, professional-grade meals or a \$[Amount] per-person buyout. 24 room-temperature bottled waters must be available backstage and on-stage.
- **Local Travel:** Complimentary parking for up to [Number] vehicles at the venue.
- **Long-Distance Travel:** For venues over [X] miles from [City], Purchaser shall provide:
 - Six (6) double-occupancy rooms at a 3-star or higher rated hotel.
 - Ground transportation or a mileage stipend of \$[Amount].

5. CANCELLATION & EXCLUSIVITY

- **Cancellation:** If Purchaser cancels within 30 days of the event, the deposit is forfeited. If cancelled within 7 days, 100% of the Total Fee remains due.
